**Gross Direct Premiums Written for
Home Insurance, 2019, 2020, 2021 and 2022:
Top 150 Insurer Groups Worldwide**

Insuramore's analysis of gross direct premiums written (GDPW) for home insurance of insurer groups in 2022 – with comparative data also included for 2019, 2020 and 2021 – covers up to the top 150 groups worldwide by this measure. Together, these 150 groups accounted for an estimated 84.4% of total global GDPW for this line in 2022.

Home insurance is defined as insurance for home buildings and / or contents acquired by private individuals including renters' and earthquake / flood cover but excluding private landlord insurance.

For insurer groups with financial year ends that occur in a month other than December, Insuramore presents data that includes a part of 2023 (e.g. end of March 2023 for many Japan-based groups).

In 2022, the top 150 insurer groups by this measure segmented by type and by home region as shown in the charts overleaf.
